

TOWN OF TREHERNE Water Rate By-Law BY-LAW NO. 891/2012

BEING a By-law of the Town of Treherne to establish sewer and water rates within the said Town of Treherne.

WHEREAS the Town of Treherne owns and operates a sewer and water facility within the limits of the said Town of Treherne.

AND WHEREAS the Municipal Act, states in part:

- 232 (1) A council may pass by-laws for municipal purposes respecting the following matters: (1) public utilities;
- 232 (2) Without limiting the generality of subsection (1), a council may in a by-law passed under this Division
- (d) establish fees and other charges for services, activities or things provided or done by the municipality or for the use of property under the ownership, direction, management or control of the municipality;"

NOW THEREFORE be it and it is hereby passed and enacted as a by-law of the Town of Treherne, in council duly assembled as follows:

THAT By-Law No. 835/03 enacted by the Town of Treherne on the 10th day of July 2003, By-Law No. 843/04 enacted by the Town of Treherne on the 23rd day of September 2004, and By-Law No. 868/2008 enacted by the Town of Treherne on 16th day of October 2008 are hereby repealed.

THAT all accounts for minimum quarterly charges for metered services as set forth in the Schedule of Quarterly Rates shall be billed quarterly in advance together with any excess charges for metered water and sewer services for the preceding quarter. Consumers shall pay for water and sewer service supplied to them by the Town of Treherne at the rates and terms set out in Schedule "A" attached hereto and forming part of this by-law.

THAT the water and sewer revised rates are to be effective October 1, 2013 and rates for 2014, 2015, 2016 and 2017 to be effective January 1 in each of those years.

THAT the 2011 operating deficit of \$44,549 and the 2012 operating deficit of \$38,500 be recovered by a rate rider of \$20.97 over a period of three (3) years; October 1, 2013 to September 30, 2016.

THAT this By-law shall come into force and become effective on, from and after both approval by The Public Utilities Board and receipt of third and final reading thereof.

3.0 -- BULK SALES RATE

All water sold in bulk by the Town of Treherne shall be charged for at the rate of \$1.82 per m³ (\$8.27) on a pro-rated basis.

4.0 -- SERVICE TO CUSTOMERS OUTSIDE OF THE TOWN OF TREHERNE LIMITS

The Council of the Town of Treherne may sign agreements with customers for the provision of water and sewer services to properties located outside of legal boundaries of the Town of Treherne. Such agreements shall provide for payment of the appropriate rates set out in the schedule, as well as a surcharge, set by resolution of Council, which shall be equivalent to the frontage levy, general taxes and special taxes for utility purposes in effect at the time, or may be in effect from time to time, and which would be levied on the property concerned if it were within the boundaries. In addition, all costs of connecting to the utility's mains and installing and maintaining service connections will be paid by the customer.

5.0 -- BILLINGS AND PENALTIES

"A late payment charge of 1 1/4% shall be charged on the dollar amount owing after the billing due date. The due date will be at least fourteen days after the mailing of the bills". And that the late payment charge will compound monthly, and will appear on the customer's next quarterly bill if unpaid.

6.0 -- CONNECTION TO WATER MAIN

Any person wishing to connect to the Town of Treherne water system shall be responsible for the installation of the water line from their residence to the town water main and shall be assessed a water connection inspection fee of \$100 that shall be paid as a lump sum fee. They shall also be responsible for all maintenance and repair of same said line.

7.0 -- DISCONNECTION

The Public Utilities Board has approved the Conditions Precedent to be followed by the municipality with respect to the disconnection of service for non-payment including, such matters, as notice and the right to appeal such action to the Public Utilities Board. A copy of the Conditions Precedent is available for inspection at the Municipality's office.

8.0 -- RECONNECTION

Any service disconnected due to non-payment of account shall not be reconnected until all arrears; penalties and a reconnection fee of \$25.00 have been paid.

9.0 -- OUTSTANDING BILLS

Pursuant to Section 252 (2) of The Municipal Act, the amount of all outstanding charges for water and sewer service are a lien and charge upon the land serviced, and shall be collected in the same manner in which ordinary taxes upon the land are collectible, and with like remedies.

10.0 -- HYDRANT RENTALS

The Town of Treherne will pay to the utility an annual rental of \$2,100.00 for 2013, \$2,163.00 for 2014, \$2,227.89 for 2015, \$2,294.73 for 2016 and \$2,363.57 for 2017 for all hydrants connected to the system.

11.0 -- SEWER SURCHARGES

- (a) Any person wanting to connect to the town main sewer line shall be responsible for all costs to install the line from their residence to the town sewer main and shall be assessed a sewer connection inspection fee of \$100 that shall be paid as a lump sum fee. They shall also be responsible for all maintenance and repair of same said line.
- (b) There will be levied annually, in addition to rates set forth above, a special surcharge on sewage having Biochemical Oxygen demand in excess of 300 parts per million, to be set by resolution of council.
- (c) A special surcharge for substances requiring special treatment shall be charged based on the actual costs for treatment required for the particular sewage or industrial wastes.

12.0 -- REQUEST TO REPLACE METER

Any water customer requesting that a water meter be replaced, shall-be charged a fee of \$25.00 (twenty five), refundable if the meter is found to not be in proper working condition.

13.0 -- METER READING

Every water customer in the Town of Treherne will be responsible for the reading of their own meter, and will be responsible for the reading to be either phoned, mailed or dropped off at the municipal office unless they have an electronic meter. Electronic meters will be read by Town of Treherne Personnel. The Town of Treherne will only be responsible for reading the non-electronic water meters when they are conducting an audit.

14.0 -- FEE FOR READING METER

Every water customer that fails to either phone, mail or drop off their water meter reading during the appropriate time schedule, will have their meter read by the Town of Treherne Personnel and be charged a \$10.00 fee for this service. If the Town Personnel are unable to access the water meter in an appropriate time frame to take a reading an estimate will be taken and the customer will still be liable for the charge.

Summary

The Public Utilities Board (Board) hereby varies the application made by the Town of Treherne (Town) and approves revised water and sewer rates for 2013, 2014, 2015, 2016 and 2017.

The new rates for 2014, 2015, 2016 and 2017 will be effective January 1 of each year. The 2013 rates are effective October 1, 2013.

The current rates as established in 2003 and the revised rates are noted below:

Background

The Town operates a water and sewer utility, consisting of a water treatment plant, water distribution mains, sewage collection mains and lagoon. The Utility began operations in 1957 with the construction of the water treatment plant. The plant was upgraded in 2003 and the equipment is well maintained and in good operating condition.

The water distribution system was put into place in 1977 with an upgrade to the reservoir at that time. No major changes to the Utility have been made since the last rate increase.

The residential water meters are 30 to 50 years old and believed to be inaccurate. A residential water meter replacement program is scheduled to start in September 2013 and be completed by the end of the year. The Town is also looking to implement a cast iron watermain replacement program, planned for 2015 to 2017.

There are currently 330 of a possible 342 water and sewer customers connected to the water and sewer systems. Although the rate By-law includes a provision for unmetered sewer customers, the Town has confirmed that all customers are metered.

There are 10 accounts that are billed yearly; three (MTS, Catholic Church and MAFRI) are year round businesses billed every January and seven are seasonal businesses that are closed during the winter. The remaining 320 customers are billed quarterly.

Two of these customers are out of Town and do not pay any additional surcharge (Treherne Diesel Repair and Potato Shed). Currently 12 accounts are closed as the buildings are vacant. The average water loss between 2009 and 2011 was 28%, notably higher than the acceptable industry average of 10%. This loss is likely caused by a combination of deterioration of main water lines and aging water meters. This combination makes it difficult to determine the actual cause of water loss through the distribution system. The Town installed new water meters for the campground, fire hall and ice plant in 2011.

The Utility is in compliance with its water treatment licenses and its wastewater treatment license.

Application

A rate study prepared by the Town's consultant was submitted to the Board on September 5, 2012, accompanied by By-law No. 891/2012 read for the first time on September 13, 2012.

The Town's rates were last set in 2003 by Board Order No. 108/03. In 2011, Board Order No. 169/11 was issued approving the recovery of the 2009 deficit of \$35,436 through the accumulated surplus. In that Order, the Town was directed to submit a statement of rate adequacy or a rate application by January 31, 2012.

A Public Notice of Application was issued on September 21, 2012,

affording customers the opportunity to comment to both the Board and the Utility with respect to the proposed increases. No stakeholder responses were received.

The Board has at its disposal two alternative processes to deal with rate applications. It may determine that a public hearing is warranted or that a paper review process is sufficient. In the case of the Town of Treherne Utility, the Board received no responses and determined that a paper review process would best serve the interests of the community and the Utility.

Deficits and working capital surplus

The Utility experienced operating deficits in 2009, 2010, 2011 and estimates that 2012 and 2013 will also result in deficits, once audited results are available. The original rate application included the recovery of the 2011 and 2012 deficits through the rates, over a five year period. The Town subsequently amended their application to request that the deficits be recovered as a rate rider over five years, in the interest of transparency.

The quarterly cost of recovery is \$12.58 per quarter over five (5) years. The Board generally prefers that deficits are recovered over a period of no more than three (3) years. The quarterly cost of recovery would increase to \$20.97 if the term were changed to three (3) years.

Cost allocation policy

The Town submitted a cost allocation methodology in May 2013. The methodology includes the *Shared Overhead Costs* such as; general administrative and shared office costs to be recovered on a flat rate basis.

The Town plans to allocate Shared Direct Operating Costs, such as; labour costs that are directly attributable to the maintenance and repair of utility assets to be recovered on an activity basis if and when they occur.

The Town has included a provision for inflation of 3% in the flat rate costs for the length of this rate application, 2013 to 2017.

Board findings

The Public Utilities Board hereby approves revised water and sewer rates for the Town of Treherne, based on the amended submission which removed the provision for recovery of the 2011 and 2012 deficits through rates.

By law, Manitoba utilities are not allowed to incur deficits. In the event that a deficit does occur, the Utility is required to obtain Board approval for a recovery methodology. The Board is therefore duty bound to approve reasonable rates based on reasonable expense projections. The Board has reviewed the Town's budgeted expenditures, and finds them to be reasonable.

The Board will vary the Town's application to recover the deficits through a five (5) year rate rider, reducing the term to three (3) years.

While the Board is sensitive to the fact that Utility customers are experiencing an increase in rates, it is in the best interest of all customers to recover the deficits over the shorter period. The longer the recovery period, the more likely it is that properties will change hands, which results in the new homeowner repaying the deficit from the former homeowner.

The Board will approve the cost allocation methodology as submitted by the Town. This methodology must be applied consistently in the future and can only be varied with approval by the Board.

The Board requires the Town to file a copy of By-law No. 891/2012 once it has been revised to reflect these changes, and received third and final reading.

Board decisions may be appealed in accordance with the provisions of Section 58 of *The Public Utilities Board Act*, or reviewed in accordance with Section 36 of the Board's Rules of Practice and Procedure.

IT IS THEREFORE ORDERED THAT:

- 1. The water and sewer rates for the Town of Treherne, as set out in Schedule "A" to this Order, BE AND ARE HEREBY APPROVED with revised rates for 2013 to be effective October 1 and rates for 2014, 2015, 2016 and 2017 to be effective January 1 in each of those years.
- 2. The 2011 operating deficit of \$44,549 and the 2012 operating deficit of \$38,500 BE AND ARE HEREBY APPROVED to be recovered by a rate rider of \$20.97 over a period of three (3) years; October 1, 2013 to December 31, 2015.
- 3. The Town of Treherne file with the Public Utilities Board a revised water and sewer By-law to reflect the decision in this Order, once it has received third and final reading.
- 4. The allocation methodology for shared services and equipment as submitted by the Town of Treherne BE AND IS HEREBY APPROVED.

3.0 -- BULK SALES RATE

All water sold in bulk by the Town of Treherne shall be charged for at the rate of \$1.82 per m³ (\$8.27) on a pro-rated basis.

4.0 -- SERVICE TO CUSTOMERS OUTSIDE OF THE TOWN OF TREHERNE LIMITS

The Council of the Town of Treherne may sign agreements with customers for the provision of water and sewer services to properties located outside of legal boundaries of the Town of Treherne. Such agreements shall provide for payment of the appropriate rates set out in the schedule, as well as a surcharge, set by resolution of Council, which shall be equivalent to the frontage levy, general taxes and special taxes for utility purposes in effect at the time, or may be in effect from time to time, and which would be levied on the property concerned if it were within the boundaries. In addition, all costs of connecting to the utility's mains and installing and maintaining service connections will be paid by the customer.

5.0 -- BILLINGS AND PENALTIES

"A late payment charge of 1 1/4% shall be charged on the dollar amount owing after the billing due date. The due date will be at least fourteen days after the mailing of the bills". And that the late payment charge will compound monthly, and will appear on the customer's next quarterly bill if unpaid.

6.0 -- CONNECTION TO WATER MAIN

Any person wishing to connect to the Town of Treherne water system shall be responsible for the installation of the water line from their residence to the town water main and shall be assessed a water connection inspection fee of \$100 that shall be paid as a lump sum fee. They shall also be responsible for all maintenance and repair of same said line.

7.0 -- DISCONNECTION

The Public Utilities Board has approved the Conditions Precedent to be followed by the municipality with respect to the disconnection of service for non-payment including, such matters, as notice and the right to appeal such action to the Public Utilities Board. A copy of the Conditions Precedent is available for inspection at the Municipality's office.

8.0 -- RECONNECTION

Any service disconnected due to non-payment of account shall not be reconnected until all arrears; penalties and a reconnection fee of \$25.00 have been paid.

9.0 -- OUTSTANDING BILLS

Pursuant to Section 252 (2) of The Municipal Act, the amount of all outstanding charges for water and sewer service are a lien and charge upon the land serviced, and shall be collected in the same manner in which ordinary taxes upon the land are collectible, and with like remedies.

10.0 -- HYDRANT RENTALS

The Town of Treherne will pay to the utility an annual rental of \$2,100.00 for 2013, \$2,163.00 for 2014, \$2,227.89 for 2015, \$2,294.73 for 2016 and \$2,363.57 for 2017 for all hydrants connected to the system.

11.0 -- SEWER SURCHARGES

- (a) Any person wanting to connect to the town main sewer line shall be responsible for all costs to install the line from their residence to the town sewer main and shall be assessed a sewer connection inspection fee of \$100 that shall be paid as a lump sum fee. They shall also be responsible for all maintenance and repair of same said line.
- (b) There will be levied annually, in addition to rates set forth above, a special surcharge on sewage having Biochemical Oxygen demand in excess of 300 parts per million, to be set by resolution of council.
- (c) A special surcharge for substances requiring special treatment shall be charged based on the actual costs for treatment required for the particular sewage or industrial wastes.

12.0 -- REQUEST TO REPLACE METER

Any water customer requesting that a water meter be replaced, shall-be charged a fee of \$25.00 (twenty five), refundable if the meter is found to not be in proper working condition.

13.0 -- METER READING

Every water customer in the Town of Treherne will be responsible for the reading of their own meter, and will be responsible for the reading to be phoned, mailed or dropped off at the municipal office unless they have an electronic meter. Electronic meters will be read by Town of Treherne Personnel. The Town of Treherne will only be responsible for reading the non-electronic water meters when they are conducting an audit.

14.0 -- FEE FOR READING METER

Every water customer that fails to either phone, mail or drop off their water meter reading during the appropriate time schedule, will have their meter read by the Town of Treherne Personnel and be charged a \$10.00 fee for this service. If the Town Personnel are unable to access the water meter in an appropriate time frame to take a reading an estimate will be taken and the customer will still be liable for the charge.
