

Municipality of Norfolk Treherne By-Law No. 74-2021 ESTABLISH A WARD SYSTEM

BEING A BY-LAW OF THE MUNICIPALITY OF NORFOLK TREHERNE TO ESTABLISH A WARD SYSTEM FOR THE PURPOSE OF ELECTING MUNICIPAL COUNCILLORS.

WHEREAS subsection 87 (1) of The Municipal Act provides as follows:

"Every member of a council is to be elected by a vote of the electors of the whole municipality unless the council by by-law provides that the councillors are to be elected on the basis of wards";

AND WHEREAS the Council of the Municipality of Norfolk Treherne deems it necessary and desirable to establish a ward system to elect municipal councillors;

NOW THEREFORE the Council of The Municipality of Norfolk Treherne, duly assembled, enacts as follows:

- 1. THAT the Municipality of Norfolk Treherne be divided into three wards, as per attached Schedule "A";
- 2. That the three wards be named as follows:
 - a. Ward 1
 - b. Ward 2
 - c. Ward 3
- That this by-law takes effect at the next general election.

ESTABLISH A WARD SYSTEM

Schedule 'A'

The councillors of the Municipality of Norfolk Treherne are to be elected on the basis of two councillors elected from each of the following wards:

Ward 1

Sections 3 to 10, 15 to 22 and 27 to 34 in Townships 7, 8 and 9 – 9 WPM; Sections 1, 2, 11 to 14, 23 to 26, E $\frac{1}{2}$ 27, E $\frac{1}{2}$ 34, all 35 and 36 in Township 7 -10 WPM; and Sections 1 to 4, 9 to 16, 21 to 28 and 33 to 36 in Townships 8 and 9 – 10 WPM (Exc Ward 3).

Ward 2

Townships 7, 8 and 9 - 8 WPM;

Sections 1 and 2, 11 to 14, 23 to 26, and 35 and 36 in Townships 7, 8 and 9-9 WPM (Exc the Village of Notre Dame de Lourdes).

Ward 3

All that portion of Section 1 which lies West of the centre line of the Boyne River, and all those portions of SE 1/4 Section 12 described as follows:

Ely 251 feet of the Wly 1153 feet of Sly 200 feet, Ely 104 feet of Wly 856.5 feet of Sly 209 feet and Ely 209 feet of Wly 753 feet of Sly 209 feet, all in Township 8-10 WPM.
